(B) Preference shall be given to such candidates having minimum one year working experience as supervisor in any canteen operated by government or private established.

Such hotels/restaurants and canteens shall deemed to be included under government establishment which are operated by Government of India or State Government or any autonomous institution/board/body under such government, whereas such hotels or restaurants shall deemed to be included under private establishment to which star ratings is given by the Hotel and Restaurant Approval and Classification Committee of India (H.R.A.C.C)
